

Application is hereby made by _____, parent, guardian, or Sponsor, (hereinafter referred to as parent) for the re-enrollment of _____ my son, daughter, ward or beneficiary (hereinafter referred to as child) in Holly Hill Academy at Holly Hill, SC (hereinafter referred to as the Academy) for the academic year 2018-2019 and agree as follows:

1. To pay current tuition and fees in monthly or yearly payments as outlined in the 2018-2019 tuition schedule. I understand that unless otherwise specified, I will be charged the amount which includes the cost of one (1) yearbook per family. The above sum is all-inclusive of tuition, textbooks, fees, etc. There is an additional \$50 for each AP Course, (Parallel readings for English classes are not included.) Tuition which is not received 10 days after the due date will be penalized an additional \$25.00 per student per month. If the amount owed is not made within 30 days of the due date, students will be removed from the rolls of Holly Hill Academy.
2. In the event the child's residence shall be removed from the area served by the Academy, this contract may be cancelled on application of the parent. Only under this condition prepaid tuition be refunded. A non-refundable administrative fee of \$200 will be assessed on all students not fulfilling their contract to the Academy.
3. A deficit budget is projected each year in order to keep tuition to a minimum. Each family is REQUIRED to participate in fundraising projects which include the Halloween Carnival, Fall Gift Wrap Sale, and the Winter Sweepstakes. If you choose not to participate in school sponsored fundraisers, your tuition will be assessed \$300.
4. Holly Hill Academy's curriculum is primarily college preparatory. We do not have the faculty or staff to adequately serve students with special needs.

The following rights and prerogatives shall be vested in the Academy:

1. To determine the class to which the child shall be assigned.
2. To suspend or expel the child for any scholastic or disciplinary reason or cause, and in the event of such suspension or expulsion, the Academy shall be the sole judge of the sufficiency of such reason or cause.
3. I understand that in signing this Tuition Contract Agreement for the upcoming school year, I agree to the rules and regulations of Holly Hill Academy as published in the Parent-Student Handbook.
